2.) Detained in Chicago Police Department lock-up or Detective facility overnight. From 10-21-2002, to; 5;14-2010.

3.) Arrested by the Chicago Police Department on suspicion of a felony without an arrest warrant and detained in excess of 48 hours without a Judicial Probable Cause hearing. from 3-15-1999, to; 2-10-2008.




