MINUTE entry before the Honorable John Z. Lee: On December 17, 2019, the Court scheduled the final approval hearing regarding the proposed class action settlement and petition for attorneys' fees for Friday, June 5, 2020, at 11:00 a.m. [388] Since that date, the COVID-19 pandemic arrived in this country, and we all have been dealing with the various restrictions that it has placed on our daily lives. The courthouse also has been closed since mid-March to minimize the spread of the virus. That said, the Court recognizes that notice of the final approval hearing already has been sent to the approximately 250,000 putative class members. Moreover, while a number of class members have submitted questions about the proposed settlement, there are very few, if any, objections, and no class member has requested an opportunity to voice an objection at the final approval hearing. Therefore, the Court finds that the interests of the putative class and the interests of justice will be furthered by proceeding with the final approval hearing as scheduled. However, to minimize the risks of spreading the coronavirus, the Court finds it necessary to conduct the final approval hearing via telephone conference. Accordingly, the final approval hearing will be conducted via telephone conference on Friday, June 5, 2020, at 11:00 a.m. The call-in number is 888-273-3658 and the access code is 1637578. Any putative class members, members of the public, and interested media also may call into this hearing.
