DURING 8-3-2005, THROUGH 8-31-2013, I WROTE SEVERAL GRIEVANCE COMPLAINTS CONCERNING THIS MATTER WHILE WITHIN COOK COUNTY JAIL DURING THAT TIME AND ALSO SENT COPIES TO BOTH HEAD ATTORNEYS FIRM JOEL A. FLAXMAN AND KENNETH N. FLAXMAN, AND THOMAS G. MORRISSEY AND PATRICK W. MORRISSEY 773-238-4235 / 312-427-9245 .

I'VE BEEN TRYING TO GET OVER TO W.I.C.C., I.D.O.L., LAW LIBRARY IN ORDER TO GO INTO MY STORED LEGAL BOXES TO RETRIEVE DOCUMENTS WHICH TO SEND YOU TO SUPPORT MY CLAIM, BUT THEY CLAIM THAT DUE TO COVID-19, CORONAVIRUS PANDEMIC, HAS EXTREMELY SLOWED DOWN SERVICE TO A LONG LIST BEING SERVED IN ORDER. I TRIED HOLDING OUT, HOPING FOR MY NAME TO COME UP ON THE LIST BEFORE YOUR 5-15-2020, DEADLINE, BUT I DIDN'T, SO I'M INFORMING YOU ( IF IT'S OKAY WITH YOU ) THAT I WILL GO RETRIEVE DOCUMENTS TO SUPPORT MY CLAIM, WHICH TO SEND YOU WHEN EVER THE LAW LIBRARY CLERK CALL ME OVER TO GO INTO MY BOXES .

ON 4-9-2020, I WROTE BOTH HEAD ATTORNEY FIRM'S, FLAXMAN AND MORRISSEY, PROVING WHY I SHOULD BE COMPENSATED AS HEAD OF THE CLASS AND ALSO I SENT A COOK COUNTY GRIEVANCE OF MEDICAL NEGLIGENCE TREATMENT, WHICH BOTH ATTORNEY'S FIRM HAVE ON FILE RECORD LOG FOR YOU TO YIELD.


IM ON FILE WRITING NUMEROUS GRIEVANCE COMPLAINT'S WHILE INCARCERATED WITHIN COOK COUNTY JAIL BETWEEN 8-3-2005, THROUGH 8-31-2013, CONCERNING MEDICAL NEGLIGENCE SERVICE TREATMENT WITHIN THE FIRST 72, HOUR'S OF NOT RECEIVING MUCH NEEDED MEDICATION, REQUEST NOR PRESCRIBED MEDICATION FOR BOTH PHYSIOLOGICAL AND MEDICAL, ON EVEN BEYOND 72, HOUR'S SUFFERING SERIOUS PAIN, NOT EATING, NOR NOT SLEEPING FOR LONG PERIOD'S HERE AND THERE, WEIGHT FLUCTUATION, MENTAL ANGUISH, WAS ALL DUE TO THE COOK COUNTY JAIL MEDICATION NEGLIGENCE INADEQUATE SERVICE THERE.

I ALSO WROTE SEVERAL MISSIVES TO BOTH HEAD CLASS COUNSEL'S LAW FIRM'S AT THAT TIME CONCERNING THIS MATTER.

I FILING NUMEROUS COMPLAINT'S CONCERNING THIS MEDICATION NEGLIGENCE INADEQUATE SERVICE WHILE THERE WITHIN THE COOK COUNTY JAIL SINCE THE BEGINNING WHAT HELPED IGNITE THIS CIVIL SUIT; PARISH V. SHERIFF OF COOK COUNTY, ET AL, 07-CV-4369, WHY I SHOULD BE COMPENSATED AS A MEMBER WHOSE HEAD OF THE CLASS.

YOU CAN CHECK BOTH OF MY PHYSIC AND MEDICAL FILE HISTORY RECORD LOG AT THE COOK COUNTY JAIL THERE UNDER DOUGLAS LEMON, I.D.
