**CITY OF EVANSTON’S UNOPPOSED
MOTION FOR AN EXTENSION OF TIME**

Defendant, City of Evanston (“Evanston”), by and through its attorneys, Tribler, Orpett & Meyer, P.C., hereby brings its Unopposed Motion for an Extension of Time to respond to Plaintiffs’ Motion for Summary Judgment and file its Cross-Motion for Summary Judgment. In response, Defendant states as follows:

1. On November 12, 2020, this Honorable Court granted Defendant’s Motion for Extension of Time and set briefing schedules for the parties’ dispositive motions. (Doc. #154). Under the current briefing schedule, Defendant is to file its cross-motion and memorandum in response to Plaintiff’s motion and memorandum in support of its motion for summary judgment by November 23, 2020. (Doc. #154).

2. Defendant seeks a one-week extension, or until November 30, 2020, to file its cross-motion and memorandum in response to Plaintiff’s motion for summary judgment and memorandum in support of its motion for summary judgment and extend the remaining deadlines by one week thereby having Plaintiff’s memorandum in reply and response in opposition to Defendant’s motion due December 23, 2020 and Defendant’s reply in support of its motion due

January 15, 2021. This is Defendant's second motion to extend the deadline to file its cross-motion and memorandum in response to Plaintiff's motion for summary judgment and memorandum in support of its motion for summary judgment. Defendant will not seek another extension of this deadline.

3. Defendant has conferred with Plaintiffs' counsel regarding this extension and Plaintiffs' counsel has no objection to this extension.

4. The purpose of this requested extension is not to unduly delay the proceedings, but is made upon current personal matters and professional assignments, including the need for time to prepare a proper response and cross-motion. The parties will not be prejudiced by this brief extension.

WHEREFORE, the Defendant respectfully requests this Honorable Court enter an order extending the time for Defendant to file its cross-motion and memorandum in response to Plaintiff's motion for summary judgment and memorandum in support of its motion for summary judgment until November 30, 2020.
