Event #07357 In summary, this is an on-view arrest by Housing Tactical Unit 264D. R/O's received information from a concerned citizen who wished to be anonymous, that several Black Males were selling drugs from the above location. R/O's immediately went to the above loc. & observed from a surveillance point Off. #1 reach inside a clear plastic bag then hand it several unknown subjects. In exchange he was given a green leafy substance. Offender's #2 to #5 were heard yelling "Blows, Blows, Blows, a street term used for heroin. R/O's then approached the subjects & announced their office. R/O's recovered from Off. #1's right hand one clear plastic bag, containing 16 ziplock baggies with a white powder substance suspect heroin. Offender's were then placed in custody per Miranda then transported to the 002nd Dist. for processing. During custodial search inside the 002nd Dist. R/O's recovered one clear ziplock bag with 49 smaller ziplock baggies filled with a white powder substance suspect heroin.
