**DEFENDANT CITY OF CHICAGO’S MOTION FOR LEAVE  
TO FILE OVERSIZED REPLY BRIEF IN SUPPORT OF ITS MOTION FOR  
SUMMARY JUDGMENT (*UNOPPOSED*)**

Defendant, the City of Chicago (“City”), submits this unopposed motion for leave to file an oversized Reply Brief In Support of Its Motion for Summary Judgment. In support thereof, the City states:

1. The City’s reply in support of its motion for summary judgment is due to be filed May 22, 2025. (Dkt. #221).
2. Arguments in the portion of Plaintiff’s Response brief directed against the City’s motion cover almost 60 pages. Due to the number and complexity of the issues required to be addressed, the City’s Reply Brief in Support of Its Motion for Summary Judgment exceeds the page limit allowed by the local rule without leave of court.
3. The City respectfully submits that its oversized memorandum of law, which consists of 25 pages, is warranted due to the number and complexity of the legal issues. The City’s brief is attached as Exhibit A.
