CONTINUATION OF NARRATIVE

THE FRONT AND REAR. UPON ENTERING THE HALLWAY R/Os OBSERVED SEVERAL PEOPLE IN LINE. AS R/O reached the FRONT OF THE LINE R/O OBSERVED OFF.#1 HOLDING A CLEAR PLASTIC BAG WITH SUSPECT NARCOTICS. R/O DETAINED OFF.#1 AND RECOVERED FROM HIS HAND THE CLEAR PLASTIC BAG. FURTHER INVESTIGATION OF THE BAG REVEALED THAT IT WAS A ZIPLOCK BAG WITH (22) SMALLER BAGGIES WHICH CONTAINED AWHITE POWDER SUSPECT HEROIN. OFF.#1 WAS THEN PLACED IN CUSTODY AND A CUSTODIAL SEARCH PERFORMED. THAT SEARCH REVEALED \$200.00 U.S.C. WHICH R/O INVENTORIED AS NARCOTICS MONEY. AS R/Os CONTINUED THEIR INVESTIGATION, THEY OBSERVED OFFS.#2 & 3 AS SUBJECTS THEY HAD PREVIOUSLY WARNED ABOUT THE SIGNS POSTED PROHIBITTING TRESSPASSING AND LOITERING.
