SUBJECT: BASIC RECRUIT TRAINING PROGRAM CURRICULUM

REFERENCE: PROGRAM TITLE: CHICAGO POLICE BASIC RECRUIT

INTENT:

Probationary Police Officers enter the Academy from all walks of life. On their first day of training, each recruit class is marked by diversity and individualism. To achieve its mission, however, the Chicago Police Department must have a common purpose, attitude, and behavior among its members. This training program is intended to instill that into every candidate who aspires to be a Chicago Police Officer. In addition, this course imparts the knowledge, hones the skills, and tests the abilities of the recruits prior to allowing their entry into the ranks of the Chicago Police Department.

SCOPE:

The program consists of 769 hours of contact between instructor and trainee. This is the "Academic" phase of recruit training. Instructional methods range from lecture, to discussion periods, to practical exercises.

The 400 hours of instructional objectives recommended by the Illinois Law Enforcement Training and Standards Board (ILETSB), are contained within this program. Successful completion of this course will prepare the recruit for the State Certification Exam and the next phase of training: "Field Evaluation."

Subject matter consists of the following categories: LAW, HUMAN BEHAVIOR, PATROL OPERATIONS, and PHYSICAL SKILLS.

GENERAL STATEMENT:

By imparting knowledge, developing skills, and molding behavior, this training program will transform civilian "individuals" into sworn "officers" of the Chicago Police Department.

When the recruit leaves the Academy and begins the Field Evaluation phase of training, he/she will have sufficient knowledge, skills, and abilities to perform the duties of a Chicago Patrol Officer under the guidance and direction of a specially-selected and trained Patrol Specialist.

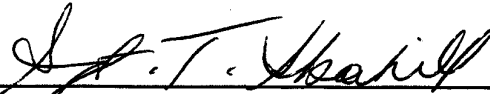

These hours are allocated by the Assistant Deputy Superintendent for special needs. Included in this category are: the Welcome Address, a session on Discipline, I.D. Photos, Red Cross Blood Donation, a Commander's Hour which is used for handing out soft body armor, an hour for distribution of helmets and batons and an hour reserved for the Fraternal Order of Police-Chicago Lodge No.7.

This hour is devoted to instructing trainees in the proper way to salute. Trainees will become proficient in saluting, which is a necessary maneuver at the graduation ceremony.

UNIFORM INSPECTION

4 HOURS

These hours are allocated for a primary and formal inspection of the recruits' uniform and equipment to ensure compliance with Department directives and the serviceability of required items. The first two hours are a preliminary inspection by Training Division Staff. The second and third hours are for the formal inspection conducted by inspectors of the Auditing & Internal Control Division.

BOMB & ARSON SECTION

1 HOUR

The trainees will be given a lecture, discussion and audio visual presentation concerning procedures and responsibilities involved in bomb threats and bombing incidents. The instructor will focus on making the trainees aware of the hazards connected with explosives and explosive devices.

MEDICAL ROLL POLICY

1 HOUR

A member of the Medical Services Section will present the trainee with the Department's medical roll policy and explain the procedures, benefits and responsibilities of Department members in using the medical roll.

Eight one-hour examinations are conducted bi-weekly. In addition, a two-hour midterm and a two-hour final exam are administered. Trainees must achieve a cumulative passing grade of 70% on these tests. Also, a Use-of-Force exam (requiring 100% performance), state firearms exam, and the State Certification Exam are administered.

CRITIQUES**STATE REQUIRED (10)****10 HOURS**

After each of the eight bi-weekly examinations, recruits are given a review of the previous test and a critique to complete. The recruits offer their opinions and suggestions on how to improve the quality of instruction and the overall program. Furthermore, recruits are given a two-hour opportunity to critique the basic recruit program, as a whole, at the end of their training.

Upon arrival at the Academy, trainees are acquainted with their responsibilities during their next twenty-four weeks. The goals of the training program are discussed, and performance standards are outlined. Rules and regulations governing their conduct in the Academy are fully explained. The final hour in this block of instruction is dedicated to Command Formations.

The purpose of this block of instruction is to provide the trainee with an overview of criminal activity as defined in ILCS 720 of the Illinois Criminal Code. Instructional emphasis throughout this course will be on the significant elements of those offenses which the recruit is most likely to encounter during the performance of regular patrol duties. State learning module: LAW.

CRIMINAL LAW UNIT (CLU)

The organizational structure of the court system, both Federal and Local, will be studied with attention directed to judicial jurisdiction, trial courts, and appellate courts. Court assignment procedures used by the Chicago Police Department will also be discussed.

CRIMINAL LAW UNIT (CLU)**235 Illinois Compiled Statutes****1 HOUR**

The primary purpose of this instructional unit is to develop the trainee's ability to recognize violations of laws regulating the possession and sale of alcoholic beverages. Subject matter will include: explanation of the restrictions on the sale of alcohol to minors; the legal elements of illegal possession of alcohol by a minor; misrepresentation of age by a minor to purchase alcohol; the law regarding open containers of alcoholic beverages in a motor vehicle; and the necessary information to gather in liquor license violations.

CRIMINAL LAW UNIT (CLU)**USE OF FORCE****STATE REQUIRED (2)****5 HOURS**

This block of instruction will provide the trainee with an in-depth understanding of the legal aspects of the use of physical force by peace officers, with reference to the case of "Tennessee vs. Garner." This will form the foundation of this course. State Learning Module: LAW

IDENTIFICATION PROCEDURES STATE REQUIRED (1)

1 HOUR

This class will explain to the trainee the three common ways used to arrive at the identification of a suspect: line-up, show-up, and photograph review. The trainees will be acquainted with the proper procedures to use and the legal challenges which can arise from their improper use. State Learning Module: LAW.

MUNICIPAL CITY CODE

3 HOURS

Trainees will be provided with a working knowledge of the City of Chicago Municipal Code, with emphasis on the sections most commonly referred to by the Patrol Officer.

JUVENILE LAW

STATE REQUIRED (8)

4 HOURS

The purpose of this unit of instruction is to develop in the recruit an understanding of 705 ILCS, - Juvenile Court Act. Statutory provisions applicable to minors such as petitions for delinquency, station adjustments, and adjudicatory hearings, will be explained.

LAWS OF ARREST, SEARCH & SEIZURE STATE REQUIRED (14) 15 HOURS

The purpose of this block of instruction is to provide the trainee with a basic understanding of the legal requirements (statutory and case law) attendant to the proper exercise of the authority vested in a police officer to arrest, search, seize, stop and frisk. Instruction will be directed not only toward the specific statutory provisions and wording of court decisions, but also toward the concepts and theories upon which these requirements are based. CRIMINAL LAW UNIT (CLU)

FIRST AMENDMENT INVESTIGATIONS

1 HOUR

This hour will provide the trainees with information regarding fundamental freedoms delineated in the 1st and 4th Amendments (made applicable to the states by the 14th Amendment) to the U.S. Constitution. The constraints under which the police must operate while conducting investigative and crime prevention functions will be explained. This is mandated by court decree.

CRIMINAL LAW UNIT (CLU)

CIVIL RIGHTS & CIVIL LIABILITY

STATE REQUIRED (2) 2 HOURS

The purpose of this unit is to make the trainees aware of not only the special rights conferred on a peace officer, but also the special responsibilities and potential liability of the peace officer and employing agency. The current directive on Civil Rights will be fully discussed with emphasis directed toward 18 U.S.C.A. 242, 42 U.S.C.S., 1983 and 105 Illinois Compiled Statutes, 5/13-2. State Learning Module: LAW.

CRIMINAL LAW UNIT (CLU)

This class is a discussion of the authority of a peace officer and the limitations of that authority with respect to the code of law being enforced, the geographic location in which it is enforceable, and the person to be arrested. Various exceptions to these limitations of law, area, and person will be explained.

CRIMINAL LAW UNIT (CLU)**LAWS OF ADMISSIONS****STATE REQUIRED (2)****2 HOURS**

The purpose of this class is to acquaint the trainees with the meaning and purpose of specific Constitutional safeguards, and with the judicial guidelines which have been established in the area of admissions and confessions. Special emphasis will be given to assure student understanding of the manner in which admissions and confessions are to be received and the consequences of failing to comply with judicial guidelines.

The concept in a criminal proceeding that a person is innocent until proven guilty is fundamental to our common law system of justice. This pre-adjudication period is deemed a very critical period in the criminal justice system, and this two-hour block of instruction will cover the rights a person is entitled to after being arrested and detained in police custody.

This policy is entitled "Protection of Life" and has been developed by a select committee to reduce the potential for the unwarranted use of deadly force while ensuring the safety of police officers and citizens alike.

CRIMINAL LAW UNIT (CLU)**RULES OF EVIDENCE****STATE REQUIRED (4)****4 HOURS**

This unit of instruction will establish an understanding in the trainee of the meaning and importance of evidence. Definitions of the various types of evidence will be explained; and legal restrictions affecting the admissibility of evidence will be explored.

CRIMINAL LAW UNIT (CLU)**CASE PREPARATION & COURTROOM TESTIMONY****3 HOURS****STATE REQUIRED (2)**

This unit will emphasize the importance of presenting a case to the prosecutor in a clear, concise and complete manner. It will also stress the essential elements for responsive and responsible officer testimony in court.

It will be emphasized that when an incident of domestic violence occurs, there is a crime; there is a victim and a perpetrator; arrest and prosecution is an appropriate response. The "Order of Protection" will also be fully discussed.

Furthermore, trainees must demonstrate knowledge and proper usage of the firearms safety center.

MILITARY DRILL & FORMATIONS	7 HOURS

By means of demonstration and individual participation in close-order drill formations, the trainee will be able to execute the military movements necessary to perform:
Academy and District inspections, revolver inspection, ceremonial movements, and Department squad and platoon formations.

Recruit officers with the pistol as their primary weapon will be familiarized with the Department-Approved revolver. Each officer will be oriented in the nomenclature and functioning of the revolvers by class presentation with red-barrel revolvers. Officers will also fire 30 rounds of ammunition for familiarization with each of the three manufacturers of revolvers. On completion the officer will possess a basic working knowledge of the revolver.

FIREARMS & DRILL UNIT (FDU)**CROWD CONTROL****4 HOURS**

Whereas the class on Crowd Behavior dealt with the behavioral aspects of individuals in a crowd, this course concentrates on specific squad and platoon movements used in crowd control. There will be emphasis on the use and care of special equipment such as helmets, gas masks and batons. Additionally, the special procedures for making arrests in a riot situation will be demonstrated and practiced.

Discussion will then move from these topics to the detrimental effects of cigarette smoking on health, physical conditioning, and the performance of police duties.

Recruits will demonstrate minimum proficiency for a safe, timely and appropriate application of dynamic response sequences within the training environment. 1 HOUR

This hour is devoted to making the trainees aware of the current technology used by the Chicago Police Department. Included in this presentation is an overview of the latest software programs used by the Chicago Police Department.

COMPUTER SKILLS UNIT (CSU)

DEPARTMENT ORGANIZATION

1 HOUR

This hour is devoted to explaining the general organizational structure of the Chicago Police Department. Chain of command, rank structure, and the functions of the various bureaus, divisions, and units of the Department are outlined.

This block of instruction will provide the trainee with knowledge of patrol techniques. Role-playing scenarios involving problematic decision-making will be included.

The Departments organizational structure and operational procedures necessary to support this concept will be explained. The individual skills necessary to become an effective member of a CAPS-oriented police department, such as problem solving, communicating and resource identification and utilization will be strengthened through discussion and practical exercises.

A representative from the Medical Services Section will also explain Medical Roll policy and procedures.

Departmental policy and procedures, as they relate to resolving disciplinary problems and the positive effects of discipline are the topics of this class. These hours of instruction explain the procedures to follow is exposed to certain diseases such as Hepatitis and Aids. The Departments Hepatitis B Vaccination Program is also explained in detail.

This class consists of lecture, discussion, and demonstrations on the appropriate use of communication techniques. Emphasis is placed on radio and telephone procedures including message formation, courtesy and basic Federal Communication Commission rules. The functions of the Communication Operations Section are explained and practice with the multi-channel hand held personal portable radio is given.

This class deals with the mechanics of safely exerting physical control over individuals occupying a motor vehicle. Lecture, discussion, and practical exercises are used to teach the proper procedures in stopping and approaching a vehicle, removing its occupants, arresting and searching suspects, and transporting arrestees in a manner which affords the greatest safety to the police officer and his/her partner.

This unit of instruction will provide the trainees with an understanding of the duties and responsibilities relevant to crimes in progress incidents. Special emphasis will be given to responsive and responsible driving, approach, arrival and on scene duties, and effective search techniques.

CRIMES IN PROGRESS PRACTICUM**STATE REQUIRED (4)****4 HOURS**

This practical exercise is intended to provide each trainee the opportunity to practice the skills taught in the class "Crimes in Progress." Trainees will develop, through hands-on experience, the skills necessary for safe response, deployment of assisting units, searching buildings, and apprehending offenders.

OPERATIONS SECTION/PATROL (OPN/P)

DESK, LOCKUP AND REVIEW OFFICE DUTIES**2 HOURS**

This class will acquaint the trainees with the numerous forms and reports prepared in a Chicago Police Department District station, such as: transmittal forms, bond books, lock-up keeper's reports, and arrest reports. An emphasis on suicides in lockups will also be included in this instruction. This block of instruction will enable the recruit to see how proper completion and utilization of these forms contribute to the achievement of the Department's goals.

OPERATIONS SECTION/PATROL (OPN/P)

COURSE TITLES & SYNOPSES**PROGRAM TITLE: CHICAGO BASIC RECRUIT OFFICER TRAINING PROGRAM****PROGRAM NUMBER: 96-005****SQUADROL DUTIES****1 HOUR**

In this class the trainee will be acquainted with Departmental policies and procedures relating to the operation of a Squadrol. The trainees will be taught how to transport prisoners (male, female and juvenile), sick or injured persons, deceased persons, police personnel, and recovered property. Current practices regarding the care and treatment of incapacitated persons will be explained. Proper maintenance and operation of squadrol equipment will also be discussed.

OPERATIONS SECTION/PATROL (OPN/P)**OFFICER SURVIVAL****9 HOURS**

Through lecture, discussion, videotape, and practicums, trainees will review the proper procedures to be used in high-risk and shooting incidents. Tactics which are helpful in reducing risk to the officer will be presented, discussed and practiced. Included are simulations of: arrests of armed suspects, removal of suspects from vehicles, searching arrestees and proper use of handcuffs. A discussion period follows the simulations for purposes of evaluation of the incident and actions taken.

Immediately prior to reporting for field training, a group of active Patrol Specialists is brought to the Academy to conduct a round-table discussion with the recruits. The topics will center around what the Patrol Specialist will expect from the recruit and what the recruit can expect from the Patrol Specialist.

1 HOUR

The trainees will be acquainted with the procedure for the use and preparation of the Ordinance Complaint to enforce violations of the Municipal Code and Park District Ordinances.

EVIDENCE AND RECOVERED PROPERTY

2 HOURS

This unit of instruction will: familiarize the trainees with the Department procedures for handling evidence and recovered property; instruct them on proper forms completion; explain policy regarding turning property over to its rightful owner; and acquaint the trainee with the procedures for court ordered disposition of evidence.

SOFT BODY ARMOR

1 HOUR

The trainee will learn the benefits of wearing soft body armor through lecture and discussion. Members of the Chicago Police Department who have been saved by wearing their soft body armor will present their story to trainees.

This unit of instruction will emphasize: the properties of fingerprints which allow their use as a positive means of identification; the use of rolled impressions in law enforcement; proper methods of fingerprinting and palm printing individuals; and proper techniques for developing and lifting latent prints.

**LEGAL ASPECTS OF CANNABIS & CONTROLLED SUBSTANCES
STATE REQUIRED (2)****2 HOURS**

These hours will acquaint the trainees with Chapter 720 ILCS and Chapter 720 ILCS, Section 635/1 of the Criminal Code. They will learn the legal elements and definitions contained in the Cannabis Control, Controlled Substances and Hypodermic Syringes and Needles Acts.
