JOINT STATUS REPORT

The parties, by counsel and pursuant to the Court's Order of May 6, 2020 (Docket No. 89), submit the following status report:

A. Progress of discovery

Discovery has been stayed pending a settlement conference with Magistrate Judge Valdez. Docket No. 77.

The settlement conference was previously scheduled for May 12, 2020, Docket No. 76, but has been stricken by the Third Amended General Order 20-0012. Docket No. 88.

B. Status of briefing on any unresolved motions

Defendants filed a motion to extend discovery for limited purposes (Docket No. 71) which the Court has entered and continued pending the outcome of the settlement conference. Docket No. 77.

No expert discovery deadlines have been set pending outcome of the settlement conference.

C. Settlement Efforts.

Counsel have exchanged settlement demands and offers. Counsel are engaged in ongoing settlement discussions and intend to continue discussions.

D. Provide an agreed proposed schedule (or alternative proposals) for the next 45 days

Parties will continue settlement discussions and await a status date to be scheduled with both the Judge and Magistrate Judge.

E. Provide an agreed proposed revised discovery and dispositive motion schedule (or alternative proposals) in cases where the current schedule needs revision

Discovery is currently stayed as mentioned above.

F. Any agreed action that the Court can take without a hearing

Not at this time.
