SEVERAL SMALL ZIPLOCK BAGGIES W/\$ SIGNS W/WHITE POWDER RESIDUE; (1) WHITE PLASTIC HANDLED WIRE MESH STRAINER W/WHITE POWDER RESIDUE; (1) CLEAR PLASTIC TUMBLER W/GREEN LID W/WHITE POWDER RESIDUE; (1) LARGE BLACK BACK-PACK BOOKBAG W/WHITE POWDER RESIDUE. IN SUMMARY: R/Os RECEIVED INFORMATION FROM A CONCERNED CITIZEN (CI) THAT "FUZZ" AKA GIPSON, LEONARD M/1/21 PACKAGES NARCOTICS AT 575 E. BROWNING APT. #604. THE CI STATED THAT "FUZZ" WOULD GO TO THAT LOCATION IN THE MORNINGS BETWEEN 0600-0630. THE CI ALSO STATED THAT LEASEHOLDER (LAWRENCE, JOYCE F/1/44) ONLY WENT ALONG WITH THESE ACTIONS IN FEAR WHAT WOULD HAPPEN IF SHE DIDNOT. R/Os ARMED WITH THIS INFORMATION SET-UP A SURVEILLANCE AROUND THE PERIMETER AND WITHIN 575 E. BROWNING. DURING THIS SURVEILLANCE R/O OBSERVED A M/B WEARING A RED LEATHER JACKET, BLUE JEANS, AND CARRYING A BLACK BACK-PACK ENTER 575 E. BROWNING. R/O RADIOED THIS INFORMATION TO THE SURVEILLANCE UNIT WITHIN THE BUILDING. THE UNIT WITHIN THE BUILDING THEN OBSERVED "FUZZ" GO TO APT. #604 KNOCK ON THE DOOR AND GAIN ENTRY. R/Os THEN BROKE THEIR POINT OF SURVEILLANCE LEAVING R/Os RIDGELL#6997 & MOHAMED#14122 OUTSIDE TO GUARD THE WINDOWS. REMAINING R/Os THEN WENT TO APT. #604 KNOCKED ON THE DOOR WHICH WAS ANSWERED BY THE LEASEHOLDER. AS THE LEASEHOLDER OPEN THE DOOR, R/O COULD SEE "FUZZ" RUN OUT OF A BEDROOM TO THE LIVING ROOM AND ATTEMPT TO THROW THE BLACK BACK-PACK OUT OF THE WINDOW. R/Os ON THE GROUND WERE RADIOING THIS ACTION TO R/Os IN THE APARTMENT AS THEY PREVENTED "FUZZ" FROM DOING SO. R/O RECOVERED THE BLACK BACK-PACK AND FOUND IT TO CONTAIN (1) LARGE PLASTIC BAG WHITE POWDER SUSPECT HEROIN. IT ALSO CONTAINED SEVERAL ITEMS WHICH ARE USED IN THE MANUFACTURING AND DISTRIBUTION OF HEROIN. ALL THESE ITEMS WERE HELD ON TO AND INVENTORIED. "FUZZ" WAS PLACED IN CUSTODY AND TRANSPORTED TO UNIT 715 FOR PROCESSING. R/Os VERIFIED THE LEASEHOLDERS INFORMATION THROUGH A RENT VOUCHER AND ILLINOIS STATE ID. THE LEASEHOLDER THEN SIGNED A CONSENT TO SEARCH FORM FOR R/Os TO SEARCH FOR OTHER NARCOTICS WHICH THE RESULTS WERE NEGATIVE.
