In Plaintiffs' Motion, you argue (in relevant part) that "Defendants do not know who the Plaintiff was calling..." Dkt. 649, p. 7. That's true for some of the calls that Defendants seek. However, when we conferred in an effort to more narrowly tailor our subpoenas to IDOC, we requested that Plaintiffs identify the unknown callers on the call logs. But Plaintiffs refused to do so.

As I explained in the meet and confer on the phone, Defendants had the opportunity to seek this information during fact discovery. Discovery is now closed (except for the handful of carve-outs in Judge Finnegan's order). Furthermore, we disagree that the information you are seeking would be available through Plaintiffs. As you know, three of these Plaintiffs are deceased. For the Plaintiffs who are alive, we believe it is unlikely they would remember phone numbers twenty years later. For Jackson, IDOC already said they don't have these calls.
