**JOINT STATUS REPORT REGARDING PROPOSED EXPERT AND
SUMMARY JUDGMENT DEADLINES**

Pursuant to the order that Judge Maldonado entered *White Sr. v. City of Chicago, et al.*, (No. 17-cv-2877) on March 5, 2024, all parties to the *White Sr.* case respectfully submit this status report with (1) an update on discovery in the consolidated proceedings; and (2) proposed deadlines for experts and summary judgment briefing in that case. Dkt. 172 in Case No. 17-cv-2877.

At the outset, the parties note that fact discovery in the test cases, including *White Sr.*, is closed other than certain depositions that Magistrate Judge Finnegan has allowed to continue past the discovery cutoff. Expert deadlines have not been set in the coordinated proceedings, and therefore the parties propose expert deadlines for the *White Sr.* case below:
