**Status Report**

Defendants respectfully submit the following Joint Status Report to update this Court on the status of pending depositions identified in their October 2, 2024 Joint Status Report (*See* Dkt. 810):

1. Attached is the updated deposition chart, which contains dates that certain depositions are currently set for or otherwise provides an update on the status of that deposition. Exhibit 1.

2. This Court previously granted the Cook County State's Attorney's Office's (SAO) request that former Assistant State's Attorney (ASA) Nancy Adduci be deposed before the remaining former ASAs (Mark Rotert, Eric Sussman, and Joe Magats), Dkt. 798, p. 7, but the SAO has withdrawn that request and has no objection to the depositions of the former ASAs taking place before the deposition of former ASA Adduci.<sup>1</sup>

3. In light of the SAO's withdrawal of that request, Defendants respectfully request that this Court permit depositions of the former ASAs to proceed without requiring former ASA Adduci's deposition to take place first.
