EVENT#04997 IN SUMMARY, R/O'S WERE CONDUCTING A NARCOTIC SURVEILLANCE AT THE ABOVE LOCATION. DURING THE SURVEILLANCE, R/O'S OBSERVED A BURGANDY MERCURY MYSTIQUE WITH ILLINOIS PLATE A82 3171 PARKED AT THE ABOVE LOCATION WITH BOTH OFFENDERS INSIDE. R/O'S OBSERVED SEVERAL UNKNOWN INDIVIDUALS APPROACH THE VEHICLE ON THE PASSENGER SIDE. THIS IS WHERE OFFENDER #1 WAS LOCATED. THESE UNKNOWN INDIVIDUALS WOULD TENDER OFFENDER #1 PAPER U.S.C. OFFENDER #1 WOULD THEN TENDER THEM SUSPECT NARCOTICS. AFTER OBSERVING WHAT R/O'S BELIEVED TO BE NARCOTIC TRANSACTIONS, ENFORCEMENT OFFICERS WERE CALLED IN. R/O UPON APPROACHING THE VEHICLE OBSERVED OFFENDER #1 ATTEMPTING TO PLACE SUSPECT NARCOTICS UNDERNEATH HIS SEAT. R/O HAD OFFENDER #1 EXIT THE VEHICLE AND RECOVERED THE SUSPECT NARCOTICS. R/O FOUND IT TO BE (7) ZIPLOCK BAGGIES WITH WHITE POWDER SUSPECT HEROIN BOUND BY A BLACK RUBBERBAND. AFTER OFFENDER #1 WAS PLACED IN CUSTODY, A CUSTODIAL SEARCH REVEALED \$280.00 U.S.C. SUSPECT NARCOTICS MONEY. OFFENDER #2 WAS MADE TO EXIT THE VEHICLE FOR OFFICER SAFETY. AS OFFENDER #2 WAS EXITING THE VEHICLE, R/O OBSERVED HIM DROP TO THE FLOOR ON THE DRIVERS SIDE A CLEAR PLASTIC BAG WITH SUSPECT NARCOTICS. R/O RECOVERED THE BAG AND FOUND IT TO CONTAIN (13) ZIPLOCK BAGGIES WITH SUSPECT HEROIN. THE BAGGIES WERE EXACTLY THE SAME AS THOSE RECOVERED FROM OFFENDER #1. A CUSTODIAL SEARCH OF OFFENDER #2 REVEALED \$21.00 U.S.C. SUSPECT NARCOTICS MONEY. BOTH OFFENDERS WERE TRANSPORTED TO THE 002 DISTRICT FOR PROCESSING.
