**JOINT STATUS REPORT**

The parties, by counsel, submit this joint status report:

1. This case was part of the *Watts Coordinated Pretrial Proceedings*, 19-cv-1717.
2. The Coordinated Proceedings were terminated on December 22, 2025. (ECF No. 827 in 19-cv-1717.)
3. This case was chosen as a test case during the Coordinated Proceedings, meaning that fact discovery specific to this case, as well as Monell discovery, is complete (except for one outstanding document that the parties are seeking from the Cook County State's Attorney's Office).
4. The parties intend to issue expert disclosures in this case and anticipate that expert discovery will largely overlap with the expert discovery conducted in other similar cases where expert discovery has been exchanged.

5. Defendants anticipate that they will move for summary judgment and expect that the arguments will in large track the arguments they made in the *Gipson* case at summary judgment.

6. The parties are mutually interested in a settlement conference as part of the global settlement talks before Magistrate Judge Valdez pursuant to ECF Nos. 842 and 843 in 19-cv-1717.
