MINUTE entry before the Honorable Jeffrey T. Gilbert: The Court set a briefing schedule on Plaintiff's Renewed Motion to Compel State's Attorney of Cook County [56] on 9/8/20 [58]. The Cook County State's Attorney did not file a response to Plaintiff's Motion [56] on the date its response was due, which was 10 days ago, and no motion to extend the filing date is of record. Plaintiff's counsel sent an email to the Court's courtroom deputy yesterday morning, 10/1/20, at 8:43 a.m., copied to the Assistant State's Attorney responsible for this matter, stating that the Cook County State's Attorney's Office intends to file a motion to extend the time to respond to Plaintiff's Motion [58] but no motion to extend has been filed. If no motion to extend is filed by 10/5/20 at 4:00 p.m. in compliance with Rule 6(b)(2), then this order shall serve as due notice that the Court intends to enter an order along the following lines: "In accordance with Local Rule 78.3, the Court has reviewed Plaintiff's Motion [58] and finds that Plaintiff is entitled to the relief requested therein. See, e.g., Bonvolanta v. Delnor Cnty. Hosp., 413 F. Supp. 2d 906, 908 (N.D. Ill. 2005); Contreras v. Suncast Corp., 129 F. Supp. 2d 1173, 1176-77 (N.D. Ill. 2001). The Court, therefore, grants Plaintiff's Motion [58] for the reasons Plaintiff has articulated in support of his Motion [58] as well as the reasons set forth in the Court's prior order concerning Plaintiff's subpoena to the Cook County State's Attorney's Office [50]. The Cook County State's Attorney's Office shall produce to Plaintiff the documents sought by Plaintiff's subpoena within 15 calendar days from the date this order is entered." Mailed notice(ber, )
