**JOINT STATUS REPORT**

The Parties, by and through their undersigned counsel, submit the following in compliance with the Court's order of February 11, 2022 (Dkt. 100):

**1. Fact Discovery Deadline**

Pursuant to this Court's order of February 11, 2022, the deadline for serving written discovery is April 18, 2022. Defendant City of Chicago has proposed dates for deposing the named Plaintiffs in May and the parties are working together to schedule these depositions. The Parties propose 90 days from the date of this status report—until Monday, July 11, 2022—for the close of fact discovery.

**2. Class Certification Deadline**

Plaintiffs intend to supplement (or amend) their motion for class certification by June 30, 2022. The parties propose the following briefing schedule:

- a) Defendant to respond to the motion by August 15, 2022;
- b) Plaintiffs to reply by September 6, 2022.
