ADDENDUM TO GENERAL ORDER 2002-2

**RE: Individuals Taken Into Custody by the Chicago Police Department with Either Outstanding Cook County Warrants or Outstanding Illinois Warrants Outside of Cook County**

1. **IT IS HEREBY ORDERED** that effective February 13, 2003, any defendant arrested by the Chicago Police Department for a new offense, either misdemeanor or felony, or a warrant issued by a First Municipal District courtroom and is found to have an outstanding Cook County warrant or an outstanding warrant issued by another county within the State of Illinois shall make their initial court appearance in the court as set forth in General Order 2002-2.
  - A. All defendants who are found to have an outstanding warrant from Cook County shall be accompanied by the warrant, a fax copy of the warrant, or an affidavit executed by a law enforcement officer verifying the existence of the warrant and the identity of the defendant. These cases shall then be placed upon the court call, bail shall be addressed and when necessary a prisoner data sheet shall issue directing the Cook County Sheriff to transport the defendant to the proper courtroom within Cook County.
  - B. All defendants who are found to have an outstanding warrant from a County in the State of Illinois, other than Cook, shall be accompanied by an Intrastate Hold Affidavit executed by the proper law enforcement officer. That affidavit shall then be attached to any paperwork generated by the Court and turned over to the Cook County Sheriff's office. In the event a defendant's case is disposed of on his initial court appearance, the Intrastate Hold Affidavit will then be given a First Municipal District docket

number. The Court shall address bail and the affidavit shall be transferred to Branch 98 for a court appearance as follows:

Monday - Wednesday

Tuesday - Thursday

Wednesday - Friday

Thursday - Monday

Friday - Monday

Saturday - Tuesday

Sunday - Tuesday

The prisoner data sheet shall also include the language that the defendant shall be released to the demanding authority should they present themselves at the Cook County Department of Corrections before the scheduled court date in Branch 98. The Sheriff may also release the defendant upon receipt from demanding authority that they have withdrawn the warrant from leads and will not take the defendant into custody on that warrant. Further, when the defendant is able to post the bail set on the foreign county warrant, the defendant shall be admitted to bail and scheduled for a court appearance in the demanding foreign county. The Sheriff shall provide the Court with verification of any of these activities upon the scheduled court date in Branch 98.

2. Any defendant taken into custody on an outstanding Cook County warrant only shall make his initial court appearance in Central Bond Court, Branch 1, and shall be accompanied by the warrant, a fax copy of the warrant, or a properly executed affidavit, at which time the Court shall address bail and transfer the case to the appropriate Cook County courtroom.
3. Any defendant taken into custody on an outstanding warrant issued outside of Cook County but within the State of Illinois only, shall make his initial court appearance in Central Bond Court, Branch 1. A properly executed Intrastate Hold Affidavit shall accompany the defendant. The affidavit shall be given a First Municipal District Docket number, bail shall be addressed and when necessary continued as follows:

Monday - Wednesday

Tuesday - Thursday

Wednesday - Friday  
Thursday - Monday  
Friday - Monday  
Saturday - Tuesday  
Sunday - Tuesday

The prisoner data sheet shall also include the language that the defendant shall be released to the demanding authority should they present themselves at the Cook County Department of Corrections before the scheduled court date in Branch 98. The Sheriff may also release the defendant upon receipt from the demanding authority that they have withdrawn the warrant from leads and will not take the defendant into custody on that warrant. - (1) Individuals with Warrants returnable within the First Municipal District are to be transported directly to the Branch Court on regularly-scheduled court date(s); on Saturday, Sunday, Holidays the Warrants are returnable to Central Bond Court.
- (2) Individuals with Warrants returnable to either the Criminal Court or a Municipal District (2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>) other than the First Municipal District are to be transported directly for their initial court appearance to 2600 South California Avenue, Chicago, Illinois.

The Cook County Sheriff shall transport individuals with Warrants returnable to a Judge at 2600 South California Avenue, Chicago, Illinois instanter to that Judge.

Those individuals with a Warrant returnable to a Criminal Division Courtroom located in the Second (2<sup>nd</sup>) and Fifth (5<sup>th</sup>) Municipal Districts, or with a Warrant returnable to a Municipal District Courtroom, shall be directed to Central Bond Court.

**RE: Individuals Taken Into Custody by the Chicago Police Department with Either Outstanding Cook County Warrants or Outstanding Illinois Warrants Outside of Cook County**

**IT IS HEREBY ORDERED that effective March 15, 2004:**

1. Any defendant arrested by the Chicago Police Department for a new offense, either misdemeanor or felony, or a warrant issued by a First Municipal District courtroom and is found to have an outstanding Cook County warrant or an outstanding warrant issued by another county within the State of Illinois shall make their initial court appearance in the court as set forth in General Order 2002-2.
  - (A) All defendants who are found to have an outstanding warrant from Cook County shall be accompanied by the warrant, a fax copy of the warrant, or an affidavit executed by a law enforcement officer verifying the existence of the warrant and the identity of the defendant. These cases shall then be placed upon the court call, bail shall be addressed and when necessary a prisoner data sheet shall issue directing the Cook County Sheriff to transport the defendant to the proper courtroom within Cook County.
  - (B) All defendants who are found to have an outstanding warrant from a County in the State Of Illinois, other than Cook, shall be accompanied by an Intrastate Hold Affidavit executed by the proper law enforcement officer. That affidavit shall then be attached to any paperwork generated by the Court and turned over to the Cook County Sheriff's office. In the event a defendant's case is disposed of on his initial court appearance, the Intrastate Hold Affidavit will then be given a First Municipal District docket

number. The court shall address bail and the defendant shall be directed to the custody of the Cook County Sheriff.

The prisoner data sheet shall also include the language that the defendant shall be released to the demanding authority should they present themselves at the Cook County Department of Corrections.

The Sheriff may release the defendant upon receipt from demanding authority that they have withdrawn the warrant from leads and will not take the defendant into custody on that warrant. Further, when the defendant is able to post the bail set foreign county warrant, the defendant shall be admitted to bail and scheduled for a court appearance in the demanding foreign county.

2. Any defendant taken into custody on an outstanding Cook County warrant only shall make his initial court appearance as delineated in General Order 2004-2 (see attached).
3. Any defendant taken into custody on an outstanding Cook County warrant issued outside of Cook County but within the State of Illinois only shall make his initial court appearance in Central Bond Court, Branch 1. A properly executed Intrastate Hold Affidavit shall accompany the defendant. The affidavit shall be given a First Municipal District Docket number, bail shall be addressed and the defendant shall be remanded to the custody of the Cook County Sheriff.

The prisoner data sheet also include the language that the defendant shall be released to the demanding authority should they present themselves at the Cook County Department of Corrections. The sheriff may also release the defendant upon receipt from the demanding authority that they have withdrawn the warrant from leads and will not take the defendant into custody on that warrant. Further, when the defendant is able to post the bail set on the foreign county warrant, the defendant shall be admitted to bail and scheduled for a court appearance in the demanding foreign county.

**IT IS FURTHERED ORDERED** that this General Order shall be spread upon the records of the court.



#### IT IS HEREBY ORDERED:

The First Municipal District's Central Bond Court shall convene as follows:

Monday through Friday      1:30 p.m.      felonies  
 (except court holidays)

Saturday, Sunday, and holidays      Noon      misdemeanors  
 1:30 p.m.      felonies

Effective March 3, 2015, the following procedures shall be followed in Municipal Districts Two through Six:

1.      A daily dedicated bond call shall be established for all hearings for the purpose of setting bail.
2.      All bond calls shall convene daily as follows:

Monday through Friday      10 a.m.      misdemeanors  
 (except court holidays)  
 1:30 p.m.      felonies

This order supersedes General Administrative Order 2014-09 (eff. November 1, 2014). This order shall be spread upon the record of this Court and published.

## GENERAL ADMINISTRATIVE ORDER NO. 2015-06 PROCEDURES FOR ARRESTS ON ILLINOIS INTRASTATE WARRANTS ISSUED OUTSIDE OF COOK COUNTY

### IN THE CIRCUIT COURT OF COOK COUNTY, ILLINOIS

### GENERAL ADMINISTRATIVE ORDER NO. 2015-06

### SUBJECT: PROCEDURES FOR ARRESTS ON ILLINOIS INTRASTATE WARRANTS ISSUED OUTSIDE OF COOK COUNTY

**IT IS HEREBY ORDERED** that, effective July 6, 2015, arresting agencies and the circuit clerk shall comply with the following procedures:

Defendants taken into custody by an arresting agency located within Cook County on an arrest warrant issued by an Illinois state court outside of Cook County shall be required to appear in bond court in the appropriate district or division of this court. A properly executed Intrastate Hold Affidavit shall accompany the defendant. The circuit clerk shall assign the affidavit an administrative case number and maintain the administrative case data in an electronic case index separate from the electronic criminal case docket.

A bail hearing shall be held, and the defendant shall be remanded by mittimus to the custody of the Cook County sheriff. The mittimus (remand order) shall direct the sheriff to release the defendant to the demanding authority if the demanding authority presents itself at the Cook County Department of Corrections.

The sheriff may also release the defendant upon receipt of notice from the demanding authority that it has withdrawn its warrant from the Illinois Law Enforcement Agencies Data System (LEADS) and will not take the defendant into custody on that warrant. Further, when the defendant is able to post the bail set on the warrant issued by the demanding authority, the defendant shall be admitted to bail and scheduled for a court appearance in the county of the demanding authority.
