**DEFENDANTS' JOINT UNOPPOSED MOTION FOR
EXTENSION OF TIME TO FILE BILL OF COSTS**

Defendants, the City of Chicago, Chicago Police Officers Robert Garduno and Anthony Spicuzza, and Chicago Police Sergeant George Davros, by and through their undersigned counsel, and pursuant to Fed. R. Civ. P. 6 and Local Rule 54.1(a), respectfully request that the Court extend the time in which Defendants are required to submit their bill of costs in this matter by seven (7) days, until October 31, 2024. In support thereof, Defendants state:

1. On September 24, 2024, the Court granted Defendants' motion for summary judgment and dismissed Plaintiff's claims. (Dkt. 141.)

2. That same day, the Court entered judgment in Defendants' favor and awarded them their costs against Plaintiff. (Dkt. 142.)

3. Pursuant to Local Rule 54.1(a), Defendants' bill of costs is currently due to be filed on October 24, 2024.

4. Local Rule 54.1(a) allows the time for filing a bill of costs to be extended on motion made within the time provided for filing. This motion, filed October 24, 2024, is thus timely.

5. Defendants require additional time to submit their bill of costs in this matter. The City of Chicago and the Officer Defendants were represented by separate counsel in this matter

and thus incurred separate costs. In order to avoid redundancy and to conserve party and judicial resources, Defendants intend to file a single bill of costs. However, counsel require additional time to coordinate this effort. In addition, defense counsel has, and has had, other professional obligations since the entry of judgment in this matter and the time for filing the bill of costs that have prevented them from preparing the necessary materials and coordinating their efforts.

6. Defendants' counsel contacted Plaintiff's counsel who does not oppose the short extension of time sought herein.

7. This brief extension of time is requested in good faith and will not prejudice the rights of any party.

WHEREFORE, Defendants, the City of Chicago, Chicago Police Officers Robert Garduno and Anthony Spicuzza, and Chicago Police Sergeant George Davros, pursuant to Fed. R. Civ. P. 6 and Local Rule 54.1(a), respectfully request that the Court extend the time in which Defendants are required to submit their bill of costs in this matter by seven (7) days, until October 31, 2024, and grant any other relief the Court deems necessary and just.
