1. The Parties are in the Process of Completing Discovery

The parties have exchanged written discovery requests. Defendants City of Chicago, Garduno, Spicuzza, and Ortiz have responded to Plaintiff's interrogatories. The parties have agreed that plaintiff, defendant Davros, defendant Doolin, and defendant City of Chicago will respond to any outstanding written discovery on or before March 15, 2021. Per this Court's January 25, 2021 Order, fact discovery shall close on June 2, 2021.

2. Discovery that Remains to be Taken

court case that forms the basis of his malicious prosecution claim against the City, and any additional witnesses identified in the course of completion of written discovery.

The parties do not jointly request a settlement conference.

5. Need for Status Hearing

The parties do not believe there is a need for the March 9, 2021 status hearing.
