NARRATIVE	<p>EVENT #14072. THIS IS A BWC ARREST, A/O'S DID NOT REVIEW FOOTAGE. IN SUMMARY, WHILE ASSISTING 306B PO ANDERSON #15660 AND PO WESTMAN #18472 ON SEARCH WARRANT #19SW4872 AT 6832 S DORCHESTER 2ND FL. UPON FORCING ENTRY INTO THE REAR OF THE UNIT, A/O'S NOTICED THE OCCUPANTS OF THE UNIT RAN OUT THE FRONT DOOR OF THE APARTMENT. UPON COMPLETION OF CLEARING THE APARTMENT, AN UNKNOWN MALE WAS DETAINED AND INFORMED OFFICERS THAT ALL OTHER OCCUPANTS OF THE UNIT RAN DOWN STAIRS TO THE FIRST FLOOR. A/O'S MADE ENTRY INTO THE FIRST FLOOR APARTMENT, AT WHICH POINT 3 ADULTS WERE DETAINED AND A HOST OF JUVENILES WERE LOCATED. WHILE SPEAKING WITH THE JUVENILES, A/O'S OBSERVED A MALE BLACK APPROXIMATELY 1 YEARS OF AGE, LATER IDENTIFIED AS [REDACTED] CHEWING ON A PLASTIC OBJECT. UPON INVESTIGATION, IT WAS DISCOVERED THAT THE JUVENILE WAS CHEWING ON A ZIP-LOCK BAGGIE OF A GREEN LEAFY SUBSTANCE (CANNABIS). UPON A THOROUGH SEARCH OF THE 2ND FLOOR, THE FOLLOWING ITEMS WERE LOCATED: 98.7 GRAMS OF CANNABIS, 8.4 GRAMS OF CRACK COCAINE, AND 33.3 GRAMS OF HEROIN. IT WAS ALSO DISCOVERED THAT ONE OF THE ADULTS THAT WERE DETAINED ON THE FIRST FLOOR, JOHNSON, TYERIE (CB #19766191) RESIDED IN THAT UNIT AND WAS THE FATHER OF THE JUVENILE THAT WAS CHEWING ON THE CANNABIS. THE OTHER TWO ADULTS WERE MURPH, JUSTIN (DOB [REDACTED] 38 AND CB #19766177) AND JOHNSON, TANZANIA (DOB [REDACTED] 91 AND CB#19766162). THE RENTER OF THE 1ST FLOOR, ARCHIE, KRYSTAL WOULD LATER ARRIVE ON SCENE AND INFORMED A/O'S THAT NONE OF THE SUBJECTS HAD PERMISSION TO BE IN THE APARTMENT AND THAT SHE ONLY KNEW JOHNSON AS THE 2ND FLOOR NEIGHBOR. JOHNSON WAS IDENTIFIED AS THE TARGET OF THE SEARCH WARRANT, AND PROCESSED UNDER THE ABOVE CB NUMBER. TANZANIA AND MURPH WAS PLACED INTO CUSTODY ON SIGNED COMPLAINTS FOR CRIMINAL TRESPASS TO RESIDENCE. THE AUNT OF JUVENILE JOHNSON [REDACTED] 83) ARRIVED ON SCENE TO TAKE CUSTODY OF [REDACTED] AND HIS THREE SIBLINGS: [REDACTED].</p> <p>WAS ADVISED THAT [REDACTED] MAY HAVE CONSUMED CANNABIS FROM THE ZIP-LOCK BAGGIE HE WAS CHEWING ON; AND SHE AGREED TO TAKE HIM TO COMER CHILDREN HOSPITAL FOR MEDICAL ATTENTION.
