Attached please find the search terms T-Mobile intends to run across its ESI custodians' files to identify documents potentially responsive to Plaintiffs' requests for production, subject to the parties' agreement regarding the scope of the requests and T-Mobile's responses and objections.

Additionally, as we have previously informed Plaintiffs, after T-Mobile runs the search terms across the custodians' ESI, T-Mobile plans to use Technology Assisted Review to review documents that hit on the search terms. Pursuant to the Order re Protocol for the Production of Electronically Stored Information (ESI), this email also serves to disclose to you "the vendor and the TAR technology or tool being used, including a description of the TAR tool's procedures." Dkt No. 181, ¶ 17.
