On page two, the pro hac vice application asks if I have ever been “transferred to inactive status, voluntarily withdrawn, or resigned from the bar of any court.” I answered “yes” because I obtained a certificate of exemption from annual filing requirements for my Iowa bar license on February 26, 2018. I did so because I lived and practiced law in New York and did not practice law in Iowa. *See* Iowa Court Rule 41.7. After briefly reactivating in 2020 and 2021, I returned to “exempt” status on February 3, 2022. While under exempt status, I cannot practice law in Iowa, but I am in good standing with the Iowa Office of Professional Regulation.
