**DEFENDANT T-MOBILE US, INC.’S AMENDED CORPORATE DISCLOSURE  
STATEMENT AND NOTIFICATION OF AFFILIATES**

Pursuant to Local Rule 3.2 and Federal Rule of Civil Procedure 7.1, Defendant T-Mobile US, Inc. (“T-Mobile”), by and through its undersigned counsel, makes the following disclosure:

T-Mobile US, Inc., a corporation organized under the laws of Delaware, is a publicly-traded company listed on the NASDAQ Global Select Market of NASDAQ Stock Market LLC (“NASDAQ”) (ticker symbol: “TMUS”).

Deutsche Telekom Holding B.V., a limited liability company (besloten vennootschap met beperkte aansprakelijkheid) organized and existing under the laws of the Netherlands (“DT B.V.”), owns more than 10% of the shares of T-Mobile. DT B.V. is a direct, wholly-owned subsidiary of T-Mobile Global Holdings GmbH, a Gesellschaft mit beschränkter Haftung organized and existing under the laws of the Federal Republic of Germany (“Holding”). Holding is, in turn, a direct, wholly-owned subsidiary of T-Mobile Global Zwischenholding GmbH, a Gesellschaft mit beschränkter Haftung organized and existing under the laws of the Federal Republic of

Germany (“Global”). Global is a direct, wholly-owned subsidiary of Deutsche Telekom AG, an Aktiengesellschaft organized and existing under the laws of the Federal Republic of Germany (“Deutsche Telekom”). The principal trading market for Deutsche Telekom’s ordinary shares is the trading platform “Xetra” of Deutsche Börse AG. Deutsche Telekom’s ordinary shares also trade on the Frankfurt, Berlin, Düsseldorf, Hamburg, Hannover, München, and Stuttgart stock exchanges in Germany. Deutsche Telekom’s American Depository Shares (“ADSs”), each representing one ordinary share, trade on the OTC market’s highest tier, OTCQX International Premier (ticker symbol: “DTEGY”).

SoftBank Group Corp., a Japanese kabushiki kaisha organized and existing under the laws of Japan (“SoftBank”), owns through its direct, wholly-owned subsidiaries more than 7% of the shares of T-Mobile. SoftBank’s direct, wholly-owned subsidiaries which make up its T-Mobile share ownership are Delaware Project 6 L.L.C., a Delaware limited liability company organized and existing under the laws of Delaware (“Project 6 LLC”); Delaware Project 4 L.L.C., a Delaware limited liability company organized and existing under the laws of Delaware (“Project 4 LLC”); and Delaware Project 9 L.L.C., a Delaware limited liability company (“Project 9 LLC”). SoftBank is a direct, wholly owned subsidiary of SoftBank Group Capital Ltd, a private limited company organized and existing under the laws of England and Wales (“SBGC”). The principal trading market for SoftBank’s ordinary shares is the Tokyo Stock Exchange (“TSE”). SoftBank’s ADSs, each representing one ordinary share, trade on the OTC pink market (ticker symbol: “SFTBY”).
