**STIPULATED SCHEDULE FOR A  
JOINT FILING REGARDING THE  
CONFIDENTIALITY ORDER**

**ORDER**

Having considered the Stipulated Schedule For A Joint Filing Regarding The Confidentiality Order (“Motion”), the Motion is granted. It is HEREBY ORDERED that the parties and non-parties shall follow this schedule including the page limitations required by paragraph 5:

1. Any Party or non-party asserting that the Confidentiality Order provides inadequate protection over certain information (“Moving Party” or “Moving Non-Party”) shall provide its proposed amendment to the Confidentiality Order and any argument in support of that amendment to the Parties by **March 28, 2025** (“Opening Positions”), which shall be exchanged among the Parties and Moving Non-Parties and not filed.

2. Any Party or non-party that is not moving to modify the Confidentiality Order (“Responding Party” or “Responding Non-Party”) may exchange a response to Opening Positions by **April 9, 2025** (“Responsive Positions”), which shall be exchanged among the Parties and

Moving Non-Parties and not filed.

3. Any Moving Party or Moving Non-Party may revise its Opening Position by **April 14, 2025** (“Final Positions”), which shall be exchanged among the Parties and Moving Non-Parties and not filed.


4. A joint filing including the Final Position of the Moving Party(ies) and Moving Non-Parties and the position of each Responding Party(ies) and Responding Non-party(ies) shall be filed with the Court on **April 17, 2025**.

5. Absent leave of the Court, the Final Positions of the Moving Party(ies) and the Final Positions of the Moving Non-Parties shall not exceed ten pages each and the positions of Responding Parties or Responding Non-Parties shall not exceed ten pages each.

6. A hearing regarding the dispute, if necessary, will be held on **April 22, 2025**.
