**DEFENDANT T-MOBILE US, INC.'S  
MOTION FOR LEAVE TO FILE DOCUMENTS PROVISIONALLY UNDER SEAL**

Defendant T-Mobile US, Inc. (“T-Mobile”) hereby moves for an order directing that an unredacted copy of T-Mobile’s Reply in Support of T-Mobile’s Motion to Compel DISH Network Corp. to Produce Discovery Responsive to its Subpoena (“Reply”) be filed provisionally under seal pursuant to Local Rule 26.2.

T-Mobile seeks to file under seal DISH’s estimated cost for custodial discovery referenced in DISH Network’s Opposition to T-Mobile’s Motion to Compel DISH Network Corp. to Produce Discovery Responsive to its Subpoena, which DISH filed under seal under the terms of the protective order in this matter. *See* Dkt. 283; Dkt. 98.
