**JOINT STATUS REPORT REGARDING CONTESTED AMENDMENTS TO THE
AGREED CONFIDENTIALITY ORDER**

Defendant T-Mobile US, Inc. (“T-Mobile”), and non-parties AT&T Mobility LLC (“AT&T”), Charter Communications Operating, LLC (“Charter”), Comcast Cable Communications, LLC (“Comcast”), Consumer Cellular, Inc. (“Consumer Cellular”), Cox Communications, Inc. (“Cox”), DISH Network Corporation (“DISH”), Google North America, Inc. (“Google”), Nsighttel Wireless, LLC (“Nsight”), U.S. Mobile, Inc. (“U.S. Mobile”), and Verizon Communications Inc. (“Verizon”) (collectively, “Mobile Non-Parties”), by and through undersigned counsel, submit this joint status report in response to the Court’s April 24, 2025 Memorandum Opinion and Order. *See* ECF No. 303.

This Court directed the parties and non-parties to meet and confer over modifications to the existing Confidentiality Order, to “attempt to reach an agreement, and [to] report back to the court in 30 days.” *Id.* at 6. Since the order issued, T-Mobile and the Mobile Non-Parties have met and conferred on multiple occasions in an effort to resolve divergent positions regarding the Confidentiality Order—particularly the scope of in-house counsel access to highly confidential

information—but these meetings were unsuccessful and T-Mobile remains at an impasse with the Mobile Non-Parties. T-Mobile and the Mobile Non-Parties refer the Court to their Joint Submission Regarding Contested Amendments to the Agreed Confidentiality Order (ECF No. 293) and will make themselves available for a hearing on the submission should the Court deem one necessary.
