On page two, the pro hac vice application asks if I have ever been “transferred to inactive status, voluntarily withdrawn, or resigned from the bar of any court.”

Under the Second Circuit’s Local Rules, “[a]n attorney is admitted for a period of five years, and must renew admission every five years for an additional five-year period. Renewal requires submission of an attorney admission renewal application.” 2d Cir. L.R. 46.1(a)(2). “After 12 months in inactive status, an attorney is removed from the court’s admission roll and must reapply for admission in accordance with [L.R. 46.1(a)(1)].” *Id.*

My admission to the Second Circuit expired in October 2020. At that time, I did not apply for renewal because I was serving in Philadelphia as an assistant district attorney, I had no cases pending in the Second Circuit, and I did not expect to have any cases pending in the Second Circuit.

I am fully eligible to be re-admitted to the Second Circuit upon application and payment of the admission fee.
