

INCIDENT NARRATIVE

EVENT#00157 FILE#17-212-191 IN SUMMARY R/O'S SET UP SURVEILLANCE IN THE VICINITY OF 313 E. 120TH PL AND SUBSEQUENTLY OBSERVED A WHITE CHEVY SUV DRIVE UP AND PARK IN FRONT OF 313 E. 120TH PL WITH 2 MALE BLACK NOW KNOW AS DENNIS JACKSON(OFFENDER) DRIVING SAID VEHICLE AND A MALE BLACK IN THE FRONT PASSANGER SEAT. WHILE ON SURVEILLANCE R/O'S OBSERVED SEVERAL NARCOTIC TRANSACTIONS WHERE ON ONE OCCASION A MALE BLACK WEARING ALL BLACK APPROXIMATELY 60 YEARS OLD 5'06 150LBS WALKED UP TO DENNIS JACKSON(OFFENDER) AND ENGAGED IN A BRIEF CONVERSATION. UNKNOWN MALE THEN TENDERED DENNIS JACKSON(OFFENDER) AN UNKNOWN AMOUNT OF U.S PAPER CURRENCY. WHERE CO-ARRESTEE WOULD THEN RELOCATE TO THE REAR OF THE RESIDENCE AT 313 E. 120TH PL. TO A VEHICLE BEARING IL REGISTRATION #S880476 EXP 03/2018. CO ARRESTEE WOULD RETREIVE A SMALL ITEM FROM A CLEAR PLASTIC BAG. CO-ARRESTEE WOULD THEN RELOCATE TO THE FRONT OF SAID LOCATION AND TENDER THE WAITING MALE BLACK SAID ITEM. THIS HAPPENED ON SEVERAL OCCASIONS, AFTER SEVERAL SIMILAR BUT UNRELATED SUSPECT NARCOTIC TRANSACTION R/O'S RADIO ENFORCEMENT OFFICER'S WITH A DESCRIPTION OF A BUYER AND DIRECTION OF FLIGHT WERE A MALE BLACK WAS POSSITIVELY IDENTIFIED BY SURVEILLANCE OFFICERS AND ARRESTED FOR POSSESSION OF A CONTROLLED SUBSTANCE RECORDED UNDER RD#JA501903. R/O'S THEN RADIOED ENFORCEMENT OFFICERS TO DETAIN DENNIS JACKSON(OFFENDER) AND CO-ARRESTEE. R/O'S RECOLATED TO THE LOCATON WHERE CO-ARRESTEE WAS RETREIVING THE SUSPECT NARCOTICS AND OBSERVED IN PLAIN VIEW ON THE DRIVER'S SEAT 2 CLEAR PLASTIC KNOTTED BAGS CONTAINING SUSPECT NARCOTICS. P.O CARRENO THEN RECOVERED SAID NARCOTICS AND FOUND THEM TO BE 2 CLEAR PLASTIC KNOTTED BAGS ONE CONTAINNG 9 SMALLER CLEAR PLASTIC KNOTTED BAGS AND ONE CONTAINING 13 SMALLER CLEAR PLASTIC KNOTTED BAGS ALL CONTAINING SUSPECT CRACK COCAINE INVENTORY#14037693. DENNIS JACKSON(OFFENDER)WAS THEN PLACED IN CUSTODY, MIRANDIZED AND TRANSPORTED TO THE 005TH DISTRICT FOR FURTHER PROCESSING. FURTHER INVESTIGATION REVEALED DENNIS JACKSON(OFFENDER) WAS DRIVING ON REVOKED LICENSE AND NO INSURANCE. R/O'S ISSUE TRAFFIC CITATIONS#TN-415-629 AND 630. DENNIS JACKSON(OFFENDER) WAS FOUND TO BE IN POSSESSION OF 790.00 USC ALL CURRENCY WAS FOUND TO BE IN MULTIPLE DENOMINATIONS AND WAS SEIZED AS SUSPECT NARCOTICS PROCEEDS INVENTORY UNDER #14037666.ARRESTEE HAS NO WANTS OR WARRANTS NOT ON GIPP, HAS ID, GANG AFFILIATION GANGSTER DISCIPLE.
