DECLARATION OF DENNIS JACKSON

The undersigned, under penalty of perjury as provided by law, declares that the following statements are true and correct:

1. My name is Dennis Jackson. I am the plaintiff in this case.
2. At my deposition, I was asked about my initial bond hearing on the drug case that is the subject of this lawsuit. I was not asked to relate everything about the hearing. Had I been asked about the following matters, I would have answered as follows:
 3. After my arrest on November 6, 2017, I spent the night in the lockup at the police station. During that time, I was not free to leave.
 4. In the early morning hours on November 7, 2017, I was transported to the courthouse at 26th and California.
 5. I waited in a lockup at the courthouse for several hours before I saw the judge. During that time, I was not free to leave.

6. I saw the judge in the afternoon and received an I-Bond.

7. I remained in custody until I was released at about 9:00 p.m.

During that time, I was not free to leave.

8. At my deposition, I was asked the following question and gave the following truthful answer:

Q. Okay. At any point, did you spend time in Cook County custody after you were I-bonded out?

A. Yes.

9. I then testified that this detention at the Cook County Jail was about two or three months after my arrest on November 6, 2017, and that it lasted for 30 days.

10. Before I gave that testimony, I had not reviewed any relevant documents.

11. I have now reviewed the attached court documents, and they have refreshed my recollection about this detention.

12. I was falsely arrested for possession of a stolen vehicle on April 14, 2018.

13. Because of the pending drug charge that is the subject of this lawsuit, I was not allowed to bond out on the stolen vehicle charge, and I entered the Cook County Jail on April 15, 2018.

14. My bond in the criminal case that is the subject of this lawsuit was revoked on April 16, 2018, because I had been falsely arrested for possession of a stolen vehicle.


15. Because my bond was revoked, I remained in custody at the Cook County Jail.

16. The charges for possession of a stolen vehicle were dismissed on April 20, 2018.

17. After the court hearing at which the stolen vehicle charges were dismissed, I was held at the Cook County Jail until April 23, 2018, when I appeared before the judge presiding in the criminal case that is the subject of this lawsuit. The judge reinstated my bond and I was released from the Jail later that day.

18. The drug charge that is the subject of this lawsuit was the only charge holding me in the Cook County Jail from April 20, 2018 and April 23, 2018.
