AGREED ORDER OF DISMISSAL

This matter coming before the Court on the Stipulation of the parties, the parties having reached agreement to settle this matter, and the respective parties being represented by counsel, Plaintiff, Michael Flagg, by his attorneys, Law Offices of Kenneth N. All the claims of Plaintiff Michael Flagg against Defendants City of Chicago, Ronald Watts, James Davis, Robert Gonzalez, Michael Spaargaren, Milan Stanford, and Carl Weatherspoon, including all claims against unknown, unidentified, and/or unserved officers and agents of the

Chicago Police Department, are hereby dismissed without prejudice, to be automatically converted to dismissal with prejudice on June 15, 2026, unless a party has moved to extend that date prior to June 15, 2026. Each side shall bear its own costs and attorneys' fees.

All other court-ordered dates and deadlines are vacated.
