
**AGREED ORDER OF DISMISSAL**

This matter coming before the Court on the Stipulation of the parties, the parties having reached agreement to settle this matter, and the respective parties being represented by counsel, Plaintiff, Joseph Thompson, by his attorneys, Law Offices of Kenneth N. Flaxman; Defendant City of Chicago, by its attorney, Mary B. Richardson-Lowry, Corporation Counsel of the City of Chicago, and Burns Noland LLP, Special Assistant Corporation Counsel; Defendant Ronald Watts, by his attorneys, Johnson & Bell, Ltd., Special Assistant Corporation Counsel; Defendant Kallatt Mohammed, by his attorneys, Mohan Groble Scolaro, P.C., Special Assistant Corporation Counsel; Defendants Rebecca Bogard, Brian Bolton, Darryl Edwards, Alvin Jones, Frankie Lane, Gerome Summers, Jr., and Kenneth Young, Jr., by their attorneys, Hale & Monico, LLC, Special Assistant Corporation Counsel; and Defendants Matthew Cadman and Michael Spaargaren, by their attorneys, Leinenweber, Baroni, and Daffada, LLC, Special Assistant Corporation Counsel; and the parties have entered into a Release and Settlement Agreement and Stipulation to Dismiss, the Court being otherwise fully advised in the premises, orders as follows:

All the claims of Plaintiff Joseph Thompson against Defendants City of Chicago, Ronald Watts, Rebecca Bogard, Brian Bolton, Matthew Cadman, Darryl Edwards, Alvin Jones, Frankie Lane, Kallatt Mohammed, Michael Spaargaren, Gerome Summers, Jr., and Kenneth Young, Jr., including all claims against unknown, unidentified, and/or unserved officers and agents of the Chicago Police Department, are hereby dismissed without prejudice, to be automatically converted to dismissal with prejudice on June 15, 2026, unless a party has moved to extend that date prior to June 15, 2026. Each side shall bear its own costs and attorneys' fees.

All other court-ordered dates and deadlines are vacated.
