## JOINT STATUS REPORT

The parties, by counsel, submit this joint status report pursuant to the Court's Order of May 19, 2025:

Defendants have answered written discovery, and plaintiff will answer written discovery by June 20, 2025. Defendants have issued ten records subpoenas and are still awaiting responses from five of the respondents. Plaintiff's deposition is scheduled for June 30, 2025. Plaintiff also seeks to depose defendants Nichols and Leano.

The depositions of Nichols and Leano will include questioning about this case and multiple other cases. Plaintiff respectfully requests that the Court permit those consolidated depositions to be held after the fact discovery deadline of July 7, 2025. The Court granted a similar request in *Robinson v. Chicago*, 20-cv-2928, ECF No. 104. Counsel for defendants Nichols and Leano does not object to this request.

The parties are communicating about settlement of various cases that were previously part of the Watts Coordinated Proceedings with the assistance of Magistrate Judge Valdez. The next conference with Magistrate Judge Valdez is scheduled for June 24, 2025.
