AGREED MOTION TO EXTEND FACT DISCOVERY CUT-OFF

NOW COMES the Defendants McHenry County, Illinois and McHenry County Animal Control Officer Jason Enos (“Enos”) by and through Patrick Kenneally, McHenry County State’s Attorney, and his duly authorized Assistant State’s Attorney, Andrew Hamilton and for their Agreed Motion to Extend Fact Discovery Cut-Off states as follows:

1. Fact discovery cut-off is scheduled for December 15, 2023.
2. Plaintiff was scheduled to be deposed on December 12, 2023. A notice of deposition was sent to and agreed upon by Plaintiff’s counsel on December 4, 2023.
3. Plaintiff and Counsel failed to appear for the deposition scheduled to occur on December 12, 2023 at 1:30 PM. Plaintiff’s counsel has apologized for his calendaring error and has assured Defense Counsel that both he and his client will appear at a rescheduled deposition.

- a. An Order extending the fact discovery cut-off to facilitate the scheduling of Plaintiff's deposition.
- b. Any and all other relief as this Court deems just and proper.
