**AFFIDAVIT OF MCHENRY COUNTY ANIMAL CONTROL OFFICER JANELLE
CARLSON**

I, Janelle Carlson, having been duly sworn under oath depose and state as follows:

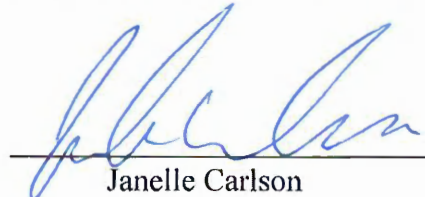
1. I am Janelle Carlson. I am over 18 years of age. I am an employee of the McHenry County Animal control department. The following paragraphs of this affidavit are based upon my personal knowledge, and, if called to testify I would testify as follows.
2. My duties consist of participating in McHenry County Animal Control field investigations and drafting reports.
3. I have participated in the animal control investigation that is the subject of the above captioned case with Officer Jason Enos.
4. It has never been the policy of McHenry County Animal Control or its officers to search a resident's mailbox.
5. It has never been the custom of McHenry County or its officers to search a resident's mailboxes.
6. On August 18 2021, Plaintiff came to the McHenry County Animal Control Offices located at 100 North Virginia Street, Crystal Lake, Illinois 60014.
7. During this encounter, Plaintiff was greeted by McHenry County Animal Control employee Dana Coon ("Coon"). Plaintiff was wearing a camera around his neck.
8. Coon offered to call the veterinarian and Plaintiff stated he was recording using his camera.
9. Plaintiff provided the name of JD for the dog and that JD was in the care of Banfield Pet Hospital in Wonder Lake, Illinois.
10. Coon made contact with a Banfield Pet Hospital located in Wonder Lake and provided the name of Monica Crosby. The veterinarian advised they did not have any dogs associated with the name Monica Crosby.
11. Plaintiff then advised the dogs name was JD Oats, and the veterinarian indicated they did not have any dogs named JD Oats in their care.

12. Coon asked for Plaintiff's name so they could look up the dog's information at the veterinarian.
13. Plaintiff refused to provide his name and Coon advised Plaintiff that he may be issued a ticket for impeding. Plaintiff refused to provide his name and indicated he was going to talk to a lawyer and left the McHenry County Animal Control Office.
14. In further discussions with the veterinarian, Coon confirmed that they have a record of a dog named "Goose Oats" located at that address, but no medical records associated with a "Goose Oats".
15. Coon performed a "True People Search" and found a Curtis Oats listed and residing at Plaintiff's residence. *See Attachment A.*
16. On August 18, 2021, at approximately 4:28 P.M. Officer Enos issued a ticket for impeding in the amount of \$100.00 to Plaintiff.
17. On December 4, 2021, due to the Plaintiff's confrontational nature, I mailed complaints for failure to vaccinate and to register to Plaintiff at Plaintiff's residence.
18. I have never spoken with Plaintiff.
19. During Plaintiff's interaction with our office, Plaintiff refused to provide necessary information needed to determine if JD was appropriately vaccinated and registered pursuant to McHenry County Ordinance regulations.
20. Plaintiff refused to provide necessary information to determine if JD was vaccinated and registered pursuant to McHenry County Ordinance regulations.
21. I issued the above-mentioned complaints because we had no opportunity to learn if JD was vaccinated and registered pursuant to McHenry County Ordinance.
22. I did not issue the complaints based upon the content of Plaintiff's expression or any statement Plaintiff made to the McHenry County Animal Control Department.
23. I issued the above-mentioned complaints because Plaintiff's actions prevented us from discovering whether JD was vaccinated and registered pursuant to McHenry County Ordinance.
24. At all relevant times, I did not have authority to issue, make, or create any policy, custom, or practice on behalf of McHenry County or the McHenry County Animal Control Department.

This concludes my Affidavit.

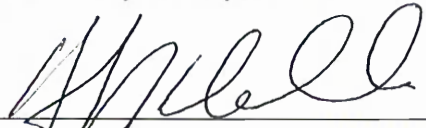

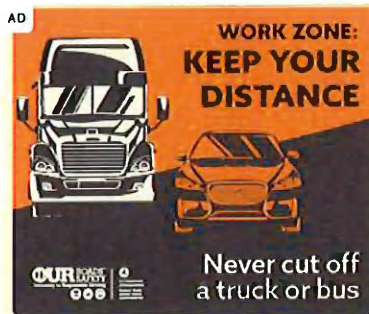
