COMPLAINT FOR VIOLATION OF ORDINANCE


The County of McHenry charges:

§ 8.04.890 Rabies - Rabies Vaccination.

A. Vaccination Requirement.

Every owner of a dog or cat (4) months or more of age, within the County of McHenry, Illinois, shall cause such dog or cat to be vaccinated by a licensed veterinarian with a prophylactic rabies vaccine approved by the United States Department of Agriculture and the Illinois Department of Agriculture.



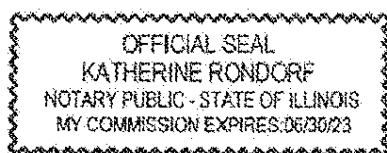
