While questioning subject, R/Is noticed pieces of ripped aluminum foil on subjects living room floor. He stated this was from residents in the house cooking, but it is indicative of an attempt to defeat the monitoring equipment. (noted in protocol notes by 3400) Subject will be reincarcerated due to on view program violation. 3400, Sgt Shavers and county dispatch notified. Subject transported to CCJ wit \$100 USC, GPS D0102562 recovered.

Upon arrival at subject host site, both Investigators had negative contact with subject, so they waited and watched. While waiting they noticed that there were no cars on side drive. This is a body worn camera incident. On 17 May 2021 Reporting Investigators Velazquez #6223 and Vasquez #6116 were dispatched to 8525 S Marquette ave due to a strap tamper and a battery critical generated by participant Henderson Tyquaun #2020-1122011. R/I's arrived to the host site and placed him in handcuffs then locked them for fit. We then began by inspecting his device and R/I's noticed a long laceration on the device and asked him how this happened. Participant stated it was due to the device being caught on something in the yard. R/I's asked him if he can show us but declined to, we also asked him why he was outside in the yard. Participant stated it was due to a family party that took place the night before and that he was drinking and was a bit intoxicated. We told him that that is another violation and he should NOT be leaving the confines of his apartment. We also told him that going into battery critical is also an EM program violation. We told him that in a matter of a few hours he accumulated three program violations. R/I's escorted participant to squad 9665 and was searched and seated with a seat belt. He was then read his miranda rights, and transported back to the custody of the CCDOC without incident. His GPS was recovered and placed in an evidence bag and turned over to Sgt Passas. Upon arrival to CCDOC he was searched again at 1040hrs by R/I Velazquez. In RCDC deputy Juton #15183 searched the participant at 1110hrs and placed him in the body scanner at 1112hrs, at this time RCDC had taken custody of Henderson without incident. All proper notifications were made, end of report.

R/D Aguilar #11296 and Inv. Tam #6107 were assigned via Protocol to Investigate the Unauthorized Leave for participant Wright, Kewon 2019-0206200/CR# SO-21-00049790. Prior to heading out to subjects address of 1115 N. Austin Basement Apt, Chicago Il 60639, Assigned units reviewed Protocol data notes. Subject left the host site at 1830Hrs on an unauthorized movement to buy medicine for his son. Subjects Unauthorized movement was at the address of 5953 W. North ave, Chicago il 60639 from 1830Hrs to 1904Hrs on the date of 08 June 21. With the information provided through Protocol Data Notes, assigned unit headed out to the host site to investigate further. Upon Making contact with the subject, Subject was aware as to why we were paying him a visit and was forthcoming with certain details. Subject admitted to leaving his host site and informed assigned units that he had taken an Uber to the convenience store to purchase medicine. Subject produced the receipt for Magic Foods located at 6020 W. North ave in Chicago il 60639. According to Intellitrak subjects high traces placed at him at a completely different address of 5953 W. North ave, Chicago Il 60639. In addition, Subject was asked to produce the Uber receipt, His response was that his girlfriend called Uber for him. Assigned units asked subject again for the uber receipt, Subject then recanted his claim that the Uber had taken him to the destination. Knowing that he was on a Suspended License, the subject asked his upstairs neighbor Walton, Joslyn to use her car to go to the store. Based on the protocol data notes and subjects actions it was determined at the time, subject had violated the Electronic Monitoring program. Subject was placed in handcuffs and was being assisted to the vehicle. R/D consulted Sgt Gatlin about the subject being Re-Incarcerated. Sgt Gatlin reviewed the assignment and had confirmed that subject was to be Re-Incarcerated. As I R/D Aguilar spoke with Sgt Gatlin in the Vehicle via county issued cell phone, Inv Tam spoke with upstairs neighbor Walton, Joslyn. Ms Walton was asked if she would be okay with watching the subjects son. She agreed and Inv. Tam asked for MS Walton ID card. The information was passed onto the subject at which time he became highly unruly. Subject began to complain of pain and demanded an ambulance. As the series of events unfolded, R/D was giving Sgt Gatlin updates. While on the phone with Sgt Gatlin, Subject became highly agitated and verbally belligerent and started kicking passenger door and window. Subject was given verbal command to stop kicking our squad door. After the Subject had calm down and stopped yelling and kicking, Assigned units were able to radio Cook County Dispatch for Chicago EMS and additional Chicago Police units. Chicago EMS# 15 arrived at 2137 Hrs at which time subject

was evaluated for his medical complaint. With Chicago Police Beat 1511 arriving at 2139Hrs Shackles were placed on subject. Subject was then assisted into ambulance. After assessment of the subject, paramedics advised officers that they would be transporting subject to west suburban hospital for further medical evaluation. As a precaution Investigator Clemons and Bradshaw were assigned to assist with subject. Subject was triaged in the emergency room and was seen by Dr. Edward Richter for his complaint of pain. Subject was given some pain medications for his pain and was then discharged from hospital. Subject was Placed back into rear of squad car for transport back to CCDOC custody. While in route back to CCDOC, subject had no further complaints of any pains without any further incidents. Subject was searched a second time at CCDOC.
