**DEFENDANT'S UNOPPOSED MOTION FOR EXTENTION TO RESPOND TO
PLAINTIFF'S SUMMARY JUDGMENT AND MOTION FOR SUMMARY JUDGMENT**

Defendants, by their attorneys, respectfully submits this second motion for an extension to respond to Plaintiff's summary judgment motion and to file Defendant's summary judgment motion, stating as follows:

1. On March 1, 2024, the Court granted Defendants' motion for a one-week extension to March 4, 2024, to file their Motion for Summary Judgement and Response to Plaintiff's Motion for Summary Judgment (collectively, Defendants Summary Judgment Filings. (Dkt. Nos. 35 and 36).
2. Defendants seek an additional two (2) days to file Defendants Summary Judgment Filings.
3. Since March 1, 2024, the undersigned has not been able to adequately complete Defendants Summary Judgment Filings due to an unforeseen health emergency of a family member. The additional time requested in this Motion will enable other attorneys of the undersigned firm to complete Defendants Summary Judgment Filings.

4. The extension requested by this Motion is not intended unnecessarily delay these proceedings.

5. Consistent with Defendants request made herein for an extension of time, Defendants respectfully request the Court enter the following briefing schedule on the parties' cross motions for summary judgment:

March 6, 2024 – Defendants to file their (a) Motion for Summary Judgment, and (b) Response to Plaintiff's Motion for Summary Judgment;

March 20, 2024 – Plaintiff to file his (a) Response to Defendants' Motion for Summary Judgment; and Reply to Defendants' Response to Plaintiff's Motion for Summary Judgment; and

April 3, 2024 - Defendants to file their Reply to Plaintiff's Response to Defendants' Motion for Summary Judgment.

6. Plaintiff does not oppose this Motion.

Wherefore, Defendants respectfully requests that this Court revise the briefing schedule with respect to Plaintiff and Defendants cross motions for summary judgment set forth above.
