NOTIFICATION OF DOCKET ENTRY

This docket entry was made by the Clerk on Tuesday, April 8, 2025:

MINUTE entry before the Honorable Young B. Kim: Defendants' motion for leave to complete certain depositions [103] is granted in part and denied in part. On March 3, 2025, this court granted Defendants leave to complete certain depositions but required them to provide more information on Michael Krejci, Sandra Greer (or Geer), and Adolpho Davis. Based on the submission and because Defendants tried to schedule Krejci's deposition a month before the fact discovery deadline, they are granted leave to depose Krejci and CCSAO. As for deposing CCSAO, Rule 30(b)(6) Topic Nos. 1–4 and 9 must be confined to information related to People v Marilyn Mulero, 92CR1308802 and People v Madeline Mendoza, 92CR1308803. As for Topic Nos. 5–8, the court finds that these topics lack the requisite particularity. Defendants may work with CCSAO to refine Topic Nos. 5–8. This ruling does not bar CCSAO from raising its objections to the Rule 30(b)(6) deposition notice. If there are objections, the burden is on Defendants to timely raise them with this court. Defendants are not granted leave to depose Greer (or Geer) and Davis. The relevant deposition testimony fails to show that the proposed depositions are proportional to the needs of this case. Plaintiffs' motion for leave to depose Joan Roberts [118] is granted for the reasons stated therein over Defendants' objections. (Plaintiffs are warned that a notice of motion is required to be filed if a motion is opposed. (See <https://www.ilnd.uscourts.gov/judge-info.aspx?IuUaWzNcEoOM6jL1OXI6+Q==>.) Parties are to complete these additional depositions by May 16, 2025. Parties are to file a joint status report on the following depositions---whether completed, scheduled, or to be scheduled---by April 22, 2025: (1) Father Jeremiah Lynch; (2) Justin Brooks; (3) Yvette Rodriguez; (4) Demaris Gonzalez; (5) Michael Krejci; and (6) CCSAO. If the parties experience scheduling difficulties, they should promptly file a motion to bring the matter to this court's attention. Parties are expected to take advantage of the multiple attorneys having appeared in this case as attorneys of record. Mailed notice (ec)
