## **ORDER OF CONTEMPT**

This order arises in response to Plaintiffs' Motion for Rule to Show Cause and Writ of Body Attachment. (Dkt. 242.) The Court scheduled the show cause hearing for June 20, 2025. (Dkt. 245.) Ms. Melloney Parker failed to sit for her deposition on June 3, 2025 and failed to appear at the show cause hearing on June 20, 2025.


The Court grants Plaintiff's motion for a contempt order and writ of body attachment against Ms. Parker. (Dkt. 242.) Ms. Parker is found to be in contempt, and the Court directs the U.S. Marshals Service to bring her to the U.S. District Courthouse, Courtroom 2239, on August 4, 2025, for her deposition. To effectuate this Order, the U.S. Marshals Service is authorized to use necessary and reasonable force to enter the premises on which Ms. Parker resides. The U.S. Marshals Service is authorized to use necessary and reasonable force to effectuate taking custody of Ms. Parker. Upon taking custody of Ms. Parker, the U.S. Marshals Service shall provide her with a copy of this Order and bring her immediately before Magistrate Judge McNally in Courtroom 2230, in order to facilitate her deposition. The deposition will proceed on that date at 10:00 a.m.

The following equipment shall be permitted into the Everett McKinley Dirksen U.S. Courthouse for the purpose of deposing Melloney Parker on August 4, 2025:

- a. A court reporter from Kentuckiana Reporters is permitted to bring: (1) reporter rolling bag (2) laptop and charger, (3) reporting stand, (4) audio mixer (5) stenography machine, (6) USB microphone, (7) external USB speaker, (8) table top microphones and ethernet cords, (9) three backup recorders, (10) power cord for stenography machine, (11) extension power strip, (12) tripod for stenography machine, (13) earbud headphones (14) pens, and (15) exhibit stickers.
- b. A videographer from Kentuckiana Reporters is permitted to bring: (1) video camera, (2) video camera case, (3) video camera power supply, (4) backup recorder, (5) power supply, (6) two HDMI cables, (7) audio mixer, (8) mixer power adapter, (9) mixer audio cables, (10) tripod for camera, (11) extension cord with power strip, (12) headphones, (13) three XLR cables, (14) table microphone, (15) three lapel microphones, (16) two SD memory cards, (17) backdrop, (18) backdrop stand, (19) deposition notice, (20) backpack, (21) laptop and charger, (22) pens, and (23) log sheet.
